ORDER

WHEREAS, it appearing to the Court that six vacancies exist on the New Mexico Commission on Access to Justice due to the expiration of the terms of Kelly Stout Sanchez, Hon. Zachary Ives, Damon J. Hudson, and Ramona Martinez Salopek, and Ernestine (Tina) Cruz and due to the resignation of Quiana Salazar-King, and the Court being desirous of filling said vacancies, Chief Justice C. Shannon Bacon, Justice Michael E. Vigil, Justice David K. Thomson, Justice Julie J. Vargas, and Justice Briana H. Zamora concurring;

NOW, THEREFORE, IT IS ORDERED that Kelly Stout Sanchez and Hon. Zachary Ives are reappointed to the New Mexico Commission on Access to Justice to three-year terms, said terms to expire December 31, 2026;

IT IS FURTHER ORDERED that Juan Abeyta, Douglas A. Echols, and Alexander F. Flores are appointed to the New Mexico Commission on Access to Justice for three-year terms, said terms to expire December 31, 2026;


IT IS FURTHER ORDERED that Teague González is appointed to the New Mexico Commission on Access to Justice to fulfill the unexpired term of Quiana Salazar-King, said term to expire December 31, 2024; and

IT IS FURTHER ORDERED that Teague González shall be eligible to serve two full three-year terms upon the expiration of her current term.
