Champions of Access to Justice



Representative Gail Chasey

Representative Gail Chasey has served in the New Mexico House of Representatives since her election in 1996 and is currently the longest-serving member of the House. Gail is a retired educator, having taught high school History and English in the Salinas Valley of California, and Special Education in the Albuquerque Public Schools. She earned a Master's and Doctorate degree in Special Education from the University of New Mexico. Gail was inspired to run for office in 1985 after working with New Mexican parents who were successful in their effort to secure public education services for children with developmental delays, ages 3-5.

Representative Chasey quickly advocated for civil rights, criminal justice reform, and equal access to justice in the Legislature. In her first session, she sponsored a bill to end filing fees for victims of domestic violence, which was signed into law. She later championed efforts to end discrimination based on sexual orientation or gender identity. Serving on the House Judiciary Committee inspired Representative Chasey to seek a law degree from the University of New Mexico School of Law while continuing to serve in the Legislature. After graduation, she began a second career as an attorney.

DISABILITY RIGHTS NEW MEXICO (DRNM)

Disability Rights New Mexico (DRNM) is an independent, private nonprofit organization that has, for over 40 years, protected, promoted, and expanded the rights of persons with disabilities. DRNM's services are free and are provided statewide. DRNM is the designated protection and advocacy program for New Mexico and has authority under federal law to pursue legal, administrative, and other remedies on behalf of persons with disabilities.

DRNM's mission is to promote the independence, productivity, and full community inclusion of persons with disabilities, facilitating consumer control of individual services, and self-help through knowledge and self-advocacy skills. DRNM services are vital to the well-being of persons with disabilities by responding to their legal needs relating to education, employment, housing, health services, protection from abuse and neglect, and fundamental legal rights.

DRNM provides several services: information and referrals about services for persons with disabilities and about their legal rights; individual case advocacy services to resolve specific disability rights problems; advocacy efforts to improve service systems; generally promote, protect and expand the rights of persons with disabilities; outreach and training activities to increase awareness of disability rights; and to increase consumer empowerment.

For many years, she served as a court-appointed attorney, dedicating her practice to abuse and neglect cases, representing children who were in state custody, or adults working to be reunited with their children. In addition to advocating for improvement in the child protective services system, Representative Chasey is dedicated to civil rights, criminal justice reform, and addressing the underlying causes of crime. In 2009, her 10-year effort to repeal the death penalty was successful. The late Governor Bill Richardson signed the bill into law and became an advocate worldwide.

A strong supporter of equal access to justice, Representative Chasey protected women's reproductive freedom while chairing the House Consumer and Public Affairs Committee for 10 years. She then chaired the House Judiciary Committee for 8 years and continues to serve on that committee and the House Government, Elections, and Indian Affairs Committee. Representative Chasey is now the House Majority Floor Leader and was one of the primary sponsors of the landmark Voting Rights Act (HB 4) enacted in the 2023 legislative session.

DRNM, in addition to providing legal assistance on individual cases, focuses on systemic advocacy on issues impacting populations with limited access to legal assistance. By targeting their resources, DRNM has been able to achieve systemic changes, including the delivery of special education services, protection from abuse and neglect, combating employment discrimination, and securing services for youth in the New Mexico foster care system.

DRNM, as part of its continuing mission, will often work collaboratively with sister organizations to address violations of legal rights and secure remedial actions for persons with disabilities. DRNM is grateful for donations to help further support their work. https://drnm.org/

Low Bono as an Avenue for Access to Justice

The AOC Court-Appointed Attorney Program (CAAP) has revised the attorney payment schedule effective September 1, 2023. The revised schedule is on the AOC Court-Appointed Attorney web page. In recognition of the time required to fulfill the duties of an appointment, the hourly rate has been raised and the hourly cap has been adjusted. The schedule describes the civil cases typically requiring court appointments, allows for atypical appointments, and the possibility for a fee adjustment for complex litigation.

"Many children in our State need the assistance of a court-appointed attorney to represent their interest in high-conflict custody disputes or when family members are caring for children of parents who are struggling. Without attorneys willing to do this work, children who need an attorney to represent their interests will be disadvantaged in our system. Increasing the compensation for these attorneys is vital given how hard and important this work is." Judge Jane Levy, Second Judicial District Court.

Representation provided by a court-appointed attorney creates a bridge over the access to justice gap. Additionally, it provides an opportunity for attorneys to explore new areas of representation and gain experience while generating income whether as a firm, solo practitioners or recently licensed attorney.

Letters of interest are always welcome and invoices can be submitted electronically to caaff@nmcourts.gov. The submission process has been streamlined and invoice forms are embedded under each representation type on the fee schedule. CAAP will activiely collect data on the number and type of court appointments across the state and develop additional improvements and adjustments as feasible.
